As you know CCE (Continuous and Comprehensive Evaluation) the flagship programme of CBSE has been implemented in all schools affiliated to CBSE in India and abroad. The CCE refers to a system of school based evaluation of student that covers all aspects of students development. It is a developmental process of student which emphasizes on two fold objectives. These objectives are continuity in evaluation and assessment of broad based learning and behavioural outcomes on the others.

The objectives of the scheme are:

- To help develop cognitive, psychomotor and affective skills.
- To lay emphasis on thought process and de-emphasize memorization.
- To make evaluation an integral part of teaching-learning process.
- To use evaluation for improvement of students achievement and teaching-learning strategies on the basis of regular diagnosis followed by remedial instructions.
- To use evaluation as a quality control device to maintain desired standard of performance
- To determine social utility, desirability or effectiveness of a programme and take appropriate decisions about the learner, the process of learning and the learning environment.
- To make the process of teaching and learning a learner-centered activity.

Needless to say that behind any successful venture there are initial challenges in effective implementation of the scheme and one of the principles for achieving success is to turn the challenges to opportunities. One of major challenges of CCE has been **the large classes** in schools. A number practising teachers and principals have been working hard to find solutions to this situation. Yet a perfect model has not been found out.

You have been in the field of schools education for number of years in different capacities and have contributed in a rich way to the cause of education.
