Chinar 9 Jawan Club, Baramulla is a vocational skill development and livelihood enhancement centre fully run by us, for the welfare of Kashmiri youth. Here, various guidance courses etc. are carried out for youths from the region for furtherance of their education, vocation and cultural values. REACHA, under leadership of Sri Nikhil Pant, has been instrumental in the success of this centre since 2016, with more than 1000 youth having already been benefitted by their support. Since 2019, REACHA is also supporting army to run its Drug De-Addiction Center at Baramulla, where more than a 1000 Kashmiri youth are being rehabilitated in a year.

He visits Baramulla regularly and interacts with the local community, the youth and with us as part of his work from REACHA. To ensure success and continuity of our efforts, he also engages closely with Corporates to raise funds/resources for projects of the Chinar 9Jawan Cub, Baramulla through Corporate Social Responsibility, and

to facilitate jobs/livelihood opportunities for the trained youth. So far, he has assisted us in raising CSR resources from Corporates like ONGC, Genpact and Aptech for the above projects.
